

ORDER APPROVING MONTHLY ACCOUNT OF COUNTY TREASURER


In the matter of the Monthly Report of Julie Frizzell, Treasurer, Dawson County, Texas.

In the COMMISSIONERS' COURT, Dawson County, Texas **April 3rd Term. A.D. 2012**




