

ORDER APPROVING MONTHLY ACCOUNT OF COUNTY TREASURER


In the matter of the Monthly Report of Julie Frizzell, Treasurer, Dawson County, Texas.

In the COMMISSIONERS' COURT, Dawson County, Texas August 7th Term. A.D. 2012


